This has reference to your application I.D. 2. An Expert Team conducted onsite evaluation of the program from **5th to 7th August, 2022**. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The program has been granted accreditation for 3 years. **Dr. Mahalingam College of Engineering and Technology, Udumaloi Road, Mackinaicken Patti Post, Pollachi- 642 003, Tamil Nadu** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
